Notes on AHI Trustee Nomination Form 2025

Background

With the creation of AHI as a **Charitable Incorporated Organisation** (CIO) on 21 September 2018, the arrangements for the election of AHI trustees are set out formally as follows:

- The Executive Committee consists of at **least six trustees**. There is no maximum number of trustees which may be appointed to the CIO.
- Trustees shall be elected to the positions of **Chair, Vice Chair, Secretary, Treasurer** and **Ordinary Trustees**.
- Each elected trustee position shall be for a term of three years.
- **Nominations are requested** for the position(s) of **Treasurer** and **Ordinary Trustee**.

Nomination Process

- All Nominees (i.e. those putting themselves forward for election as an AHI Trustee)
 must be either an individual AHI member (Student, Associate, Full, Fellow, or
 Honorary) or the nominated representative of an AHI Corporate membership.
- All those proposing a member for election as a trustee must themselves be either an individual member or the nominated representative of a corporate member.
- All nomination forms must be signed by the Proposer.
- **All nomination forms must be signed by the Nominee** to show his or her willingness to be appointed.
- Remember to complete all the boxes and provide a supporting statement.
- Send the **fully completed form** to the AHI Administrator, 25 Recreation Way, Kemsley, Sittingbourne, Kent, ME10 2RD. (Scanned copies sent by email to admin@ahi.org.uk will be accepted)
- The closing date for receipt of completed forms is **Friday**, **19**th **September 2025**.

What happens next?

- As there is no maximum number of trustees who may be appointed to the CIO, all eligible nominations will be deemed as elected.
 - The new committee will be announced at the AGM which will be held on Thursday, 9
 October 2025 between 08:30am and 09:15am as part of the AHI conference being held at the Holiday Inn® Cardiff City Centre, Castle Street Cardiff, CF10 1XD.
